• Due to the ongoing pandemic, the 2021 deadline for Peer Reviews has been moved to April 30th. Peer Reviews are due every other year or when a Treasurer, DC, or RS change. Please Contact Deb Kirsch if you need help with the review process.

- Year-end financial Reports should have already been uploaded to the USPC Database via the club/center profile page. If you haven't filed yet, you are late and must do so ASAP.
- These reports are essential because The National Office files the State's Charitable Registration for us. To do this, they need your Year-end Financial Statements. It is imperative as the states have not extended the charitable registration deadlines as they did in 2020.
