#### Middle California Region and Goals for 2021

The MidCal Region's current number of members is 185 dispersed across 14 Clubs and 6 Centers. We are well on the way to our average of 250 members.

In the past several years, the Region has improved communication and encouraged our clubs/centers to share resources. We have made progress, especially since 2020 has given us no choice but to work together, including our wider community. Some new goals for 2021 are to work as teams to reduce stress among the region's leadership, build a catalog of important information that is easy to access, and include Club/Center programs open to all regional members on our website calendar.

Our RICs are working on gathering other regional instruction resources. We now have *guidelines for using Upper-Level members as instructors and examiners* available on the website. We launch our emerging instructor program this year.

The Region is working to be able to offer safe in-person Rallies and Certifications for our members. We have made a few changes to help our members a little more financially to meet Rally, Certification, or Camp expenses. This year we have introduced <u>The Middle California</u> Region's Essay Scholarship Fund.

2021 is still a Festival year when members meet to participate in Championships and educational opportunities at the Kentucky Horse Park in Lexington, KY. We want to support our members wishing to participate, whether through a Rally or if it has to be attained by an alternate route. The region will be covering all of the Championship's registration fee. We are also asking for those with interest in Rallies, Certification, and Championship to let your DC/CA and fill out an intention to participate.

## **Land Conservation/ Land Stewardship and Pony Club**

Equestrian Land Conservation is a topic that should be near and dear to the heart of all of us and is required knowledge in Pony Club Certifications. In recent months, two-horse facilities with strong ties to MidCal Pony Clubs and historical equine contributions to their communities are threatened with closure and equestrian use of the land removed. California's Del Mar Horse Park is also under threat. I will also express MidCal's Gratitude to Terry Hilst for her purchase of Fresno County Horse Park after John Marshall announced his retirement.

The First Facility to come to my attention is the Marina Equestrian Center run by the Marina Equestrian Association. This facility hosts Santa Cruz County Pony Club meetings and MidCal Regional events. This facility is where D Camp was held in 2020. Petitions were circulated, and letters were written to Marina City council, and that made a difference. The Facility is still not completely safe from danger. The Marina City Council released a call for vendors to submit plans of use proposals for the property. The Property is to be renamed Marina Equestrian Center Park. The Marina Equestrian Association, which is led by Nichole Fisher (SCCPC's DC and a MidCal VRS), responds with a plan of use for the facility. Pony Club is putting our support behind the MEA and their proposal for lease and property use.

The second property that is just getting its fight rolling is Coastside Corral/Sweeny Ridge Equestrian in Pacifica. Sweeny Ridge Equestrian is the home of the California Riding Academy Pony Club Riding Center. The property is privately owned and was put up for sale. The prospective buyers intend to change the property use from commercial outdoor recreation/horse use to inconsistent use with how it has historically been used and the desires of the greater community. Concerned Pacifica citizens and other parties are petitioning the City of Pacifica to grant the property Historic Landmark Designation and protection or preservation. The petitioners are also asking the city to deny any temporary use permits and prevent any alterations to the property and structures until the full historical importance of the property can be determined.

You may ask why this is such an important property that Pacifica's citizens and the Bay Area Equestrian community are upset.

- It is the last facility on the Northern San Francisco Peninsula of its size with a covered arena.
- Current property use minimally impacts the environment and provides the area with recreational and economic opportunities.
- The property includes open space and trail access to historical parts of the GGNRA.
- That with the current zoning, the property should have been safe.

## Little bit more Background

According to the late mayor Grace McCarthy, the property initially had an excess of 500 acres. Mayor McCarthy expressed concern about the reduction of this historic site's property over 50 years ago. Coastside Corral was an integral part of the City of Pacifica's early development era and has been operating since pre-incorporation days.
